AMPLIFY YOUR SAVINGS

IRA Charitable Rollover

If you're 70½ years or older, you can transfer up to \$100,000 per year from your IRA directly to ECF without having to pay income taxes on the money. This gift can also count toward your required minimum distribution (RMD) if you're 73 or older.

WHY CONSIDER A QUALIFIED CHARITABLE DISTRIBUTION (QCD)?

Tax-Free Giving: A QCD allows you to make a tax-free gift directly from your IRA to ECF. This is particularly beneficial if you don't need all of your RMD for personal use.

Meet Your RMD: If you're 73 or older, a QCD can satisfy all or part of your required minimum distribution, reducing your taxable income.

Support ECF's Mission: Your QCD will directly benefit the Evanston community by supporting ECF's initiatives and programs aimed at fostering equity, opportunity, and resilience.


