Regardless of the type of security, or if wiring cash, your gift will be directed to the Foundation's investment account at Charles Schwab, our primary custodian. Specific instructions, by type of transaction, are presented below. If you or your broker encounter any difficulties, please let us know, and we'll coordinate with the head of our investment committee to ensure the transaction will be handled properly.
