# **Grassroots Community Groups and Emerging Nonprofits**

In alignment with The Evanston Community Foundation (ECF) <u>strategic plan</u>, the foundation aims to build justice and resiliency while connecting and strengthening Evanston. This strategic pilar translates into our grantmaking through our continued commitment to advance racial equity and trust-based philanthropy best practices.

ECF has dedicated this grant cycle to prioritize support to grassroots community groups and emerging nonprofits that demonstrate a strong commitment to racial equity in mission, vision, values, and work. This grant opportunity is designed to provide unrestricted, flexible general operating funding to support any and all expenses related to operating and sustaining work addressing systemic inequities in the Evanston Community.

### **Evanston Community Foundation Mission Statement**

Our mission is to mobilize community resources to drive systemic social change and build a thriving, resilient Evanston. We achieve this by:

- Investing in community with a long-term and sustainable perspective
- Empowering leaders to foster innovation and collaboration
- Prioritizing community voice and choice

## **Funding Priorities**

We fund community partnerships that:

- Address a systemic inequity in the Evanston Community
- Led by, for, and with <u>Black, Indigenous, People of Color (BIPOC)</u> and prioritize community voice and choice.

<sup>&</sup>lt;sup>1</sup> ECF uses the term BIPOC to highlight the unique history of oppression and continual, systemic discrimination that Black and Indigenous people experience within a U.S. context. These systems, built on white supremacy culture, impact all People of Color. As such, ECF prioritizes organizations led by and/or centered on the voices of Black, Indigenous, Latine, and Asian community members, and those impacted by multiple intersectional systems of oppression

### **Eligibility**

This checklist will help applicants evaluate eligibility for this grant opportunity. Please review the following information carefully before beginning an application:

- Who can apply:
  - Applicants must fit in one of the following categories:
    - **a) Emerging Nonprofits**: 501c3 organizations, 501c6 organizations, local schools, local government, and community organizations with a fiscal sponsor.
    - **b)** Grassroots Community Groups: Any group of community members working together to address a community need no 501c3, 501c6 or fiscal sponsorship required.
- Applicants must have an operating budget size of \$500,000 or less
- Applicants must have an Evanston address and serve the Evanston community through their work and mission
- Applicants must demonstrate a strong commitment and presence in Evanston to serve the community
- Applicants must demonstrate strong commitment to racial equity through the organization's mission, vision, values, and work

#### **Funding Guidelines**

- Applicants may submit requests up to \$25,000
- This grant term runs 12-months

#### This grant opportunity will not support:

- Organizations who have already received a Spring 2024 Nonprofit Growth and Sustainability General Operating grant
- Endowments
- Fundraising or sponsorship of one-time events
- Scholarships
- Requests for individual benefit
- Faith-based institutions that appeal for solely religious purposes and do not serve the general community.

## **Evaluation Criteria**

At ECF, we practice community-led grantmaking meaning that we intentionally shift grant decision making power to the Evanston community. The grantmaking committees are comprised of individuals of diverse identities and lived experiences who all live, work, play, and learn in the Evanston Community. These are individuals deeply connected to the issues we are trying to address through our grantmaking and who have shown meaningful civic engagement and learning. Applications will be evaluated using the following core criteria that reflects ECF mission, vision, values, and commitment to racial equity:

- Vision and Plan
- Racial Equity and Diversity, Equity and Inclusion Practices
- Evanston and Community Impact
- Systems Change
