
## A Vibrant Illinois Depends on a Vibrant Democracy

## **Bootcamp for New Nonprofit CEOs**



Axelson Center's BootCamp for New Nonprofit CEOs is being held August 1-3, 2018 at North Park University. This year's program fee is \$895. A \$200 scholarship is available to participants from organizations with a budget size under \$1 million. The application deadline to apply is June 22, 2018. They allow a maximum of 40 nonprofit CEOs into the program. Participants should have 3 years or less experience as a nonprofit ED/CEO and be able to commit to the full three days of BootCamp.

# **Statewide call on Federal Regulations: A message from Illinois Partners for Human Services**

Dear Illinois Partners,

Immigration is the wind in our country's sails---it is the labor, skills and ideas that move our country forward. But did you know that the federal government is preparing to issue regulations that would further limit access to a wide range of public assistance programs for immigrants, including nutrition assistance through SNAP and WIC, healthcare coverage under Medicaid and the Affordable Care Act, and refundable tax credits, among others? Our immigration policies should treat everyone with the compassion they deserve as human beings. No matter where we were born, we are all people and our immigration laws should recognize this. Treating all people with compassion should guide our actions as we set out to improve our immigration system.


